 - 1. Physical abuse (e.g. strike, shake, slap)
 - 2. Verbal / Mental abuse (e.g. humiliate, degrade, threaten)
 - 3. Sexual abuse (e.g. inappropriate touch, or exposure)
- 5. I will not possess or use illegal drugs. I will not possess or use alcohol or tobacco in the context of ministry.
- 6. I will not use or tolerate profanity in the presence of children.
- 7. I understand that any violation of this Code may be grounds for dismissal, discipline, or other action by the Church.
