INTRODUCTION

Title: in Hebrew: *Devarim* — “Words” (1:1)

In the Septuagint (LXX): *Deuteronomion* —
“Second Law” (17:18)

Author: Moses

Theme: Explanation of the Law to a new generation.

Purpose: Moses exhorted Israel to be faithful to Yahweh and to the Sinaitic Covenant so that she might go in and possess the Land, though He foretold that Israel would fail to obey Yahweh in the Land (1:5).

- 40th yr and 11th month
after leaving Egypt ~ 1406
B.C. (1:3).
