## HOPE2021

### Waiver of Liability/Assumption of Risk and Responsibility

#### Ridgecrest Property:

While Ridgecrest will try to maintain its facilities in good repair, every user of Ridgecrest's facilities has the obligation to exercise care and caution in using all facilities, grounds, and equipment solely for their intended purposes. By signing this agreement, you acknowledge and agree that every group and/or individual user of Ridgecrest's facilities:

- (i) assumes the risks inherent in the facilities, grounds, equipment and activities of Ridgecrest;
- (ii) will pay for any damage to the facilities, grounds or equipment they cause or to which they contribute; and
- (iii) expressly waives and releases LifeWay, Restored Hope Network and Ridgecrest from liability for any injury or loss occasioned by any use of the facilities, grounds or equipment of Ridgecrest that is inconsistent with their intended use or purpose, inconsistent with due care and caution or inconsistent with the terms of this agreement.

#### Covid-19 Preventative Measures

Ridgecrest has evaluated local, state and federal government and health department guidelines and their policies for guests and staff are located [here](#).

**Self-Check Prior to Gathering Each Day**---Before coming to HOPE2021 and each day, all staff and attendees are expected to self-screen. Screening should include a check for any of the following symptoms:

- Feeling feverish, having chills, or temperature 100.4°F or higher
- New or unexplained persistent cough
- Shortness of breath
- Difficulty breathing
- Loss of taste or smell
- Fatigue
- Muscle aches
- Headache
- Sore throat
- Nausea or vomiting
- Diarrhea
- Runny nose or congestion

Anyone who feels ill and/or is experiencing any of the above symptoms prior to arriving is **required** to notify us and not to come to Ridgecrest. Those experiencing symptoms after arrival must remain in their room separately until leaving Ridgecrest. and the contact number that will be shared at the event. Reach out to a health care provider about COVID-19 testing and next steps for treatment.

Staff or attendees who reside with or have come in close contact with a person who is experiencing symptoms or is confirmed with COVID-19 are also required to stay home and should immediately inform the Restored Hope office of the situation.

All those who attend or serve at HOPE2021 assume the risk of attending

**Health Services:** Neither Restored Hope Network, nor Ridgecrest employ medical professionals, nor do we stock medical supplies or equipment. We will assist with first aid and public emergency services.

**Severability:** If any provision or term of this agreement should be held legally unenforceable for any reason, all remaining provisions and terms shall remain in full force and effect.

**Waiver:** The registrant/guest voluntarily agrees to participate in HOPE2021 sponsored by Restored Hope Network from June 10-13, 2021

The registrant/guest recognizes that Restored Hope Network has not undertaken any duty or responsibility for his or her safety and the undersigned agrees to assume the full responsibility for all risk of bodily injury, death, disability, and property damage as a result of participating in HOPE2021.

The registrant/guest also attests that they are physically fit to participate in walking around the Ridgecrest campus or any other activity he or she decides to partake in.

By registering, I hereby state that I understand the risks involved in participating in HOPE2021 and willingly and voluntarily accept these risks. By my registration, I hereby surrender any right to seek reimbursement from Restored Hope Network and its directors, officers, employees, volunteers and other agents for injury sustained and liability incurred during my participation in the activity described above. By my registration, I warrant that I am not relying on any oral representations, statements or inducement apart from the statements made on this form.
