The Financial Story of the 2022-23 fiscal year at Taft Ave.

Here are a few facts about our last fiscal year:

We are ending the fiscal year under budget and in the black. We owe nothing, and we lived within our means.

Giving: We project that we will end the year with \$410k in actual giving (\$333k last year), which represents a **25% increase in** *actual* **giving over last year**.

Average Weekly Attendance: Our average weekly attendance is **165** [In person = 124 (up 10); online streams = 21 (down 1)]. In 2022 it was 158; in 2021 it was 131; and in 2018 it was 96. We have grown 26% from two years ago, and 72% from 2018.

Average Weekly Giving: Our average weekly giving is up from \$6.4k/wk to \$8k/wk.

We are thrilled that you all prioritize giving to the Lord of your resources, and we are also honored that our leadership is trusted, and continues to earn the trust, to steward that giving.

As a reminder: We don't give to *the church*, we give *to the Lord*, *through* the church. Our job as elders and staff is to steward that giving in the most strategic way possible for kingdom impact in our city and with our partners.

The Financial Story of the 2023-24 proposed budget at Taft Ave.

We continue to account for growth and an increase in the budget. This coming fiscal year budget (what we are approving on Sunday, June 25, 2023) reflects a **24% increase**.

The Budget is largely identical to last year on most line items (within a few hundred dollars). However, there are **three areas** where we are seeing significant increases:

- 1. **Utilities Costs:** Utilities costs are **up from 18%-25%.** We know that you all are experiencing that in your household budgets. Our budget reflects that. Gordon has watched that number throughout the year and so we have budgeted for a 30% increase in the utilities line.
- 2. **Capital Improvement Fund:** We have written in *a new line item* into Taft Ave and Children's House budgets. **We are placing \$2k a month from both budgets (TACC and CH; \$4k total) into our capital improvement fund (Total of \$48k).** In the past we have paid for capital improvements (Roofs, Community Center walkway, AVL Sanctuary project) out of our operational account. We are adding a new

account where we essentially save for and pay for Capital Projects for both Taft Ave and Children's House. That fund right now is robust after receiving ERC funds last fall, but we want to plan to replenish that fund to the tune of \$48k every year. This will fund our costs on deferred maintenance as well as capital improvements across the campus.

3. **Personnel:** We are also seeing increase in our personnel line on the budget. We have brought on a **Facilities Assistant** in Murph Carey. We added an additional **Office Admin** position with Sandra Phipps, and we are increasing our investment in our **Youth Ministry Director** position by increasing Andrew Tierney from half-time to three-quarter-time. Andrew was married this Summer, beginning seminary in the Fall, and continues to show his growing pastoral impact in our community. **We continue to prioritize the development of younger ministry leaders**. Adelee Smith has been a blessing as a Worship Director. We are anticipating bringing on summer interns to serve in Youth and Kidmin, and looking to bring on more interns as the ministry year progresses and funding continues. Marcia Lichte continues to provide leadership for our growing KidMin and Alana Zheng is one of our most valued assets as our Office Manager. On the Children's House side, Deanne Walkwitz is moving forward with great vision for what God can do with our ministries to families there.

We are excited about God's movement. Great is His faithfulness! We anticipate that God is going to move in this next year, and this budget reflects some of the areas where we want to invest and be ready for opportunities to arise.
