## Statement of Cooperation— Summer Camp

**FINANCES:** We understand it is vital that parents pay tuition for the amount stated on the Registration form. We understand Summer Camp tuition is paid through the FACTS Management Company and is automatically drafted each Monday of the weeks that were registered for. When summer camp and after school tuition overlaps you may contact the financial office for extra time and special arrangements. All payments are made via the FACTS management system. Families who have accounts with payments not made on time or insufficient funds will receive a \$25.00 late fee applied to their account. No late fees will be waived unless special arrangements have been made in advance with the Financial Office. The student may not return to After School or Summer Camp until the account is made current. Any balance 2 weeks past due and without contacting the Financial Office to make arrangements will result in suspension of services. The student may return to Summer Camp as soon as the bill is paid in full if the space has not been filled. Any balance 60 days past due will result in the student being released from school. We further understand that there are no refunds or transfer of fees to other children or other school years for the Registration fees. All fees are due in full and are non-refundable.

**SCHOOL ACTIVITIES:** We give permission for our child(ren) to take part in any and all school activities, class field trips, including sports and school-sponsored trips away from the school premises, and absolve the school from liability to us or our child because of an injury to us or our child at school or during any school activity. In case of emergency or illness, we request the school contact us first. If we are not available, please contact the designated emergency contact. If the emergency contact cannot be reached, the school has our permission to make whatever arrangements deemed necessary for our child(ren)'s treatment. If the emergency is life-threatening, emergency personnel will be contacted in addition to contacting us or an emergency contact if we cannot be reached. The physician has permission to act accordingly absolving the school of any liability. This statement of cooperation will serve as a blanket permission slip from May 1, 2019 to August 30, 2019. In order to help ensure the safety of our students, Triad Baptist Christian Academy has an established volunteer policy that is outlined in the Student/Parent Handbook. We understand that in order to participate as a volunteer, we will abide by the guidelines set forth in the volunteer policy and complete any necessary forms. Triad Baptist Christian Academy is committed to ensuring that your privacy is protected. TBCA will use personal information, such as e-mail addresses and phone numbers, for school-related communication inclusive of third party services. Personal information will not be shared, sold, or distributed outside of this ministry. We likewise, understand that we need to complete the Opt-in form for our child (ren)'s picture to be used in any TBCA publication, website, social media site and outside publications. I understand that any picture used for any TBCA publication, website, social media site and outside publications will be without any compensation to me, my family and my child(ren).

**DISCIPLINE:** We believe discipline is a necessary aspect of our child(ren)'s education. We give permission for our child(ren)'s teacher and/or administration to make and enforce classroom regulations in a manner consistent with Christian principles and discipline as set forth in Scriptures. Parents will be sent written notice of such assignments. We understand that we have the responsibility to actively support the authority, philosophy, objectives, policies, procedures, and discipline of the school as established by the School Board.

**PARENTAL COMMITMENT:** We agree that we will in no case complain to other parents but will register only our necessary complaints with the teacher or administration following the Matthew 18 principle. We pledge our full cooperation to keep doctrinal controversy out of the school. We agree to support the school with our prayers and positive attitude. We understand that if at any time the school determines, in its absolute and sole discretion, that our actions do not support the ministry, or reflect a lack of cooperation and commitment to the home and school working together, the school has the right to request the withdrawal of our child(ren). We understand that the school reserves the right to dismiss our student(s) for lack of cooperation on the part of the student, parent and/or guardian. Admission to Triad Baptist Christian Academy is a privilege and not a right. It is a privilege granted with the understanding that students will desire to live as Bible-believing, consecrated Christians.

**STATEMENT OF FAITH:** We agree with the Statement of Faith as laid out in the TBCA Student/Parent Handbook. We have read and understand the Statement of Faith and have no discrepancies with our moral and religious standards.
